Dawn Furney – Owner of Dawn's restaurant voiced her concerns about the Green Egg Fest. She indicated that last year when this event was going on, all of her parking spaces that her customers use, was taken by people who were cooking at the Green Egg Fest. She had to close her business early, which cost her money, due to lack of business.

Carl Thornton – Business owner and resident of Colon expressed his disappointment in building decision. Never received an answer about general fund, no update on financial meetings, very disappointed about the way Linda has been treated by another council member. He feels that the council member should be forced to resign.

Eddie made a negative comment while Carl was speaking and Village President, Sharon Craun, told Eddie he was out of line.

Keith Stickley – Colon Resident. He was very concerned with the nonsense that is going on in this Village. His family has invested in this community. Heartbroken to see the nonsense that was posted on social media. The present pro-tem was out of line with the comments that he made on social media about another council member. Social media post was personal not political. Liable and Slanderous. He expressed that there were more important issues at hand that we should be focusing on. Trees in the right of way, sewage plant is an issue, etc. Supposed to be a representative of all of us. Step up and be a leader. Change to do better. Apologize to the Village.

Brandon Baker: He thinks Green Egg Festival is a good event for Colon and he feels that the Village missed an opportunity on Marijuana – he brought some numbers for the council to review.
Kurt Kuhlmann – Vacancy Pastor at the Lutheran Church. Would like to see sidewalk to connect from the apartments to the burr oak road intersection. He sees a lot of litter along the roadway.

Police Chief Report

Chief Brinkert – He proposed that we put the 2007 squad car up for sealed bids

Office Manager Report

Billi – Submitted her report. Comment about sidewalk fund in the amount of \$10,000 non-motorized construction. Doesn't have to do with roads. We haven't spent any at this point. Cathy, Auditor, said it can come from the local roads.

Fire Board Report - Marilyn

88 calls total (Fire – 8, Good Intent calls – 8, Hazardous Condition (No Fire) – 1, Rescue & Emergency)
New Fire Truck inspection is complete. Fire Department will be picking the New Fire Truck up soon.

Lake Board – Ed Bell

Jim Crawford – was in a severe snowmobile accident so it was good to see him at the meeting.
Approved contracts with Progressive A & E and for weed control. We are considering a chemical that deals with algae – it is on a test basis. It is a costly expense, but we are taking it into consideration. If approved, then we will do this in warmer weather. Our next meeting is Saturday, April is 9 am board at 10 am. We approved to change our meeting to August 20 so there was not conflict of interest with the Green Egg fest. Our revenue – still total of 480460 is our revenue total. Sidewalks – there is a clear pathway to school is a program where there was a lot of funds for Colon. This still might be an option.

Planning Commission - Kurt Kuhlman

We would like to add Kelsey Lynch to our planning council. If she is appointed to the position, they would like to change the meeting to the 4th Monday of the Month @ 6:00 p.m. starting April 25th.

We have discussed changing the price. It is a cost of \$30 to keep the electricity boxes. Linda questioned why they were opening early then we are supposed to. Mickey said they made a special exception due to the nature of the business that wanted to go in. Marilyn suggested that we send Jim Avery a thank you note for putting up the pop ups this year without cost.

Mickey said the DDA would like to have their own bank account with Sturgis bank to streamline our efforts. Sharon suggested that we need to have this discussion with Billi to see if this process will work for us. Billi said that she has already had discuss with them on this. They need to figure out how to get Circa into their account. They would like to have their DDA meetings @ 5:30 second Tuesday of the month before council meetings.

This will be determined month by month as the personnel committee, and other council uses the Village Office prior to meetings.

Title company could not determine ownership. Looking at moving it over so it is in the right of way. If not, we could possibly get an easement. Go to court and get approval. There is a lift station at the end of the street – he will check to see if we can use this.
